NOTIFICATION REQUIREMENTS

IMPORTS, COASTAL, TRANSHIPS and TRANSIT

The Shipping Line must provide operations@timarucontainerterminal.co.nz with the following no less than 48 hours prior to Vessels Pro Forma ETA

1. Hazardous Manifest
2. Dangerous Goods Documents
3. For DMV classes the Consignee and Transport Coy contact details

EXPORTS and OUTBOUND COASTAL

The Shipping Line must provide operations@timarucontainerterminal.co.nz with the following

1. Hazardous Manifest at Cargo Cut Off
2. For DMV classes the Shipper and Transport Coy contact details
